
Most Reverend Archbishop Charles J. Chaput, O.F.M. Cap. Archbishop of Philadelphia

STUDENT ACCESS & ACHIEVEMENT INITIATIVE

LEVERAGING STRATEGIC INVESTMENTS SYSTEM-WIDE

During the 2016-2017 school year, Faith in the Future and the Office of Catholic Education continued to develop and invest in the **Student Access & Achievement Initiative**. Now that our schools are on a stronger financial footing, we raised funds and invested growth capital for the investment areas outlined below that all our schools could benefit from, but none would be able to address solely on their own. Our plan built on our proven track record of results to date and aimed to significantly expand access to underserved students and accelerate academic achievement for all system-wide.

FOCUS AREAS

- Urban Education Initiative: Increase access to underserved students and families in urban areas within the Archdiocese of Philadelphia. These investments will increase success rates of students by increasing passing rates, increasing retention rates, and providing much-needed social services to families.
- Special Education Initiative: Enhance access to students with special needs in our four schools of special education and broaden inclusion among all K-12 schools. Particular attention will be given to the needs of children identified on the autistic spectrum. These investments will increase student achievement, increase the number of children we serve with special needs, and improve our institutional advancement capability to sustain this effort.
- **Technology Initiative**: Create a state-of-the-art educational technology platform upon which all of our schools can improve and grow. We will upgrade the infrastructure of our high schools and create 21st-century classrooms where teaching and learning are driven by technology integration across the curriculum.
- Academic Performance Initiative: Produce 21st-century learning environments with a special focus on improving critical reading skills, high school readiness, college counseling, educational leadership coaching, and increasing access to blended learning platforms.
- People Development Initiative: Attract, develop, and retain current and emerging top-tier Catholic leaders committed to our educational mission and quality goals through leadership training, executive coaching, mentor networks, and development of non-teaching school staff.
- Enrollment Growth and Marketing Initiative: Increase student enrollment and retention rates by focusing on the individual needs of students and families of diverse backgrounds.

In the following pages of this Annual Report, you will see successful examples of the Student Access and Achievement Initiative that have already been put into action. The Summer Bridge Program, Technology Infrastructure Rebuilds, the Principals Leadership Academy, and hiring a Director of Institutional Advancement for the Schools of Special Education have been steps along the path of providing better access for all students.

In school districts like Philadelphia that have struggled to produce results and provide a valuable education, we must be the catalyst for change. We have the people, the leadership, the schools, and the opportunity to make a change for Philadelphia.



After its fifth year of operations, Faith in the Future is showing signs of a maturing organization: we have built a core team of professionals at the home office; we are driving more quarterly and annual results to goal by measuring for performance along the way; and we continue to attract proven leaders from business and other walks of life to join our Board of Directors and breathe even greater strength and vitality into this developing institution.

Many of the numbers featured in this annual report demonstrate this maturing and strengthening of our core capabilities. For the fifth year in a row the high schools raised significantly more money than the year before; teaching and learning in our schools is more data-driven and augmented by the power of new technologies in the classroom; and our talent management department continues to attract accomplished leaders from many different fields of endeavor to run our schools and perform the hard work of rebuilding them for the future.

But the most decisive work commissioned by the Board and performed over these last 12 months was an internal strategic planning effort to answer the question: what do we need to do differently to strengthen these schools over the long haul and make an institution that is truly built to last?

Working with Parthenon/EY, a boutique strategy consulting firm, the answer to this question has come in the form of three strategic recommendations that the leadership team of Faith in the Future and the Office of Catholic Education believe are critical to our shared success from here. Together, these three recommendations have the power to transform our current system of schools into a true educational powerhouse that could positively transform the lives of our students for many generations to come.

The three-part blueprint for the next phase of our work, then, is as follows:

School-Level Improvement Planning: use a data-driven analysis of the local competitive situation at each of our schools today to articulate a clear and compelling value proposition for each school that will win in its local market.

New School Support Model: intentionally place our schools at the top of the support structure — make our resources at the center more flexible and adaptive to individual school needs — while at the same time more prescriptive of those shared services that can support schools with similar needs more efficiently and more cost effectively.

Simplified Organizational Structure: to support all of this work, flatten the organization, simplify the reporting structure, and above all else make it easier for the schools to get the specific help they need to meet their local challenges.

All of this is now underway and these are exciting times for this work. Without a doubt the days ahead will present some real challenges that will require of many people the continued generosity, hard work, and openness to new things that have gotten us this far. But we have a clear plan, the goodwill of so many great supporters, and now a shared vision that sees what must be done differently for this great opportunity to be realized. We are more confident than ever in the work ahead knowing that what has been built so far is just a strong foundation upon which to build an even stronger institution. As I leave the organization, I know I am leaving one that is built to last, and one which will continue to make an impact on our students for many years to come.








Class of 2017 Destination



"A number of years ago, I was contacted by Brother Richard Kestler. At that point I got involved with fundraising for West, and then later with the school board. Being on the board gave me a lot of insight into the school and what they were doing. And that really motivated me in terms of thinking more about providing a significant donation to West Catholic," Len said of his position as a school-level donor and a donor to FIF. And I think Faith in the Future stepped up to a significant challenge to save Catholic schools and Catholic education in the Philadelphia Archdiocese, and that's something that is so noteworthy and is worthy of people donating. The commitment being made by everyone at Faith in the Future shows that if you really bear down on the challenges there you can come up with solutions that work."

With the goal of making Philadelphia the best city in the country to be a Catholic school leader, we continue to recruit the best people available. In hiring Jason Bozzone as the President of Pope John Paul II High School (PJPII), we have gained another strong leader with innovative ideas, creative management approaches, and forward-thinking vision.





Jason began his tenure as President July 11, 2016, coming from Temple University. This background in higher education has allowed him to understand student, alumni, and parent stories, and helped him work with each group to be successful.

"We need to inspire and motivate our young people to seize the day. My graduate program in College Student Personnel at Bowling Green State University and professional experiences at a variety of universities provided me with the blueprints to know the important work we need to provide for student success," Bozzone shared. GOVERNANCE

A NEW MODEL FOR OUR HIGH SCHOOLS

Beginning in 2015, the Archdiocesan high schools began transforming their volunteer school advisory boards into boards with specified jurisdiction, which would serve as true governing bodies for each school. As of January 2017, Faith in the Future and the Office of Catholic Education held a training for the third and final cohort of schools to launch these new boards, marking a successful transition to this new governance model.

The strategy behind establishing these boards of specified jurisdiction is to entrust our schools with more local authority and drive greater accountability and decision-making to the school level. Whenever possible, decisions about a school's direction are best made locally by school leaders who know and understand the needs of their school community. The school boards are designed to assist our school leaders by focusing primarily on the business aspects of the school where board members can bring new resources and expertise through finance, marketing, enrollment, development, and facilities management.

In 2015, in partnership with the Office of Catholic Education, Faith in the Future funded an engagement with the Healey Education Foundation to establish a clear set of by-laws that would guide the new boards and provide a framework for their work. Each board is now tasked with establishing a clearly defined value-proposition, long-range goals, and ultimately a school level strategic plan that will grow and sustain their school.

The establishment of high school boards has also marked an opportunity for Faith in the Future's board to look inward to further develop its own guidelines and operating principles, revise its by-laws, and study its committee structure to ensure each has a charter appropriate for the Foundation's work. The FIF Governance Committee set goals for the 2016-2017 year to include finalizing a handbook of standard operating principles covering areas of academics, finance, enrollment, development, and governance; and implementing a system-wide plan of professional development and best practices in governance and board development that will include ongoing training in all areas of institutional advancement.

"By building our Faith in the Future Governance Committee with clear principles, we are able to serve as a model for the way we want our high school boards to operate," says Stan Silverman, chair of the FIF Governance Committee. "This system-wide practice encourages our boards to bring local resources and better business practices to serve the direct needs of their students."

IN THEIR OWN WORDS

SCHOOL BOARD REFLECTIONS

"The board is a very diverse board, mostly an inner city board, men and women who want to give something back to the city. Since Roman is right smack in the middle of the city, they identify Roman as being part of the downtown work environment, so they appreciate the opportunity to work with young people who will have an effect on the workforce of the city when they graduate. From the alumni point of view, our attitude has been that it's time to give back to Roman Catholic High School because it gave so much to all of us. If you look at Barry Howard, a Jewish guy from Cleveland, he's done so much pro bono work and runs the Finance committee at Roman — he does it because he wants to give back to young people today in the city of Philadelphia. I'm involved because the school gave a lot to me, and you have to give back. I get more out of it, you get more out of it than you give."

The Bonaventure Program is a thriving program at Archbishop Ryan. One of the goals to better serve our students who need special education or extra support is to create similar Learning Labs at all of our high schools as part of our Student Access & Achievement Initiative. Support such as the Bonaventure Program provides is growing in Archdiocesan High Schools. Now, with the support of the Access and Achievement funds, more than fifty percent of our schools offer similar support. Neumann-Goretti and Little Flower host the newest Learning Labs, started in the fall of 2017.

CUSTOMIZED LEARNING

FINDING THE RIGHT SUPPORT FOR EVERY STUDENT

In 1995, the Bonaventure Program at Archbishop Ryan began with 15 freshmen. Every year since, additional students have joined the program designed to aid students with various learning needs. These students face a variety of challenges — 90% have a language-based learning disability, whether with written expression, oral expression, or dyslexia, while others struggle with math-based learning issues, ADHD, or an autism spectrum disorder of one kind or another.

The Bonaventure Program is not a school within a school, like Our Lady of Confidence upper school at Bishop McDevitt or the St. Katherine Day School program at Archbishop Carroll. Instead, the Bonaventure Program supplements Archbishop Ryan's existing curriculum. All of the students have a regular roster and come in for a learning strategies class once a day. In addition to their learning strategies class, the Bonaventure Program teachers touch base with each student's academic teachers to find out what support each student needs to be successful, and supervise tests for all of their students' classes in the Bonaventure Center.

This individualized learning support has created a strong support system for each student. The teachers in the Bonaventure Center have a dynamic relationship with each student, and a strong rapport with parents. The parents are so appreciative of the attention their children get, working with their teachers until they are confident they can tackle any subject.

"Our teachers in the Bonaventure Program have an amazing combination of love and toughness for these kids. All kids need people to believe in them and challenge them. Because of the teachers' background in special education and their devotion to Catholic school, these kids are pushed hard but they always have a soft place to land. It's a very special thing and an amazing thing to watch. It's an orchestra of a thousand moving parts and it's beautiful the way it works," shared teacher Nancy Kerz.

Over the last 22 years, the graduates have gone on to attend trade school, join the military, become part of the workforce, or attend a two-or-four-year college. Despite any learning disability, they are encouraged to continue their education post-secondary. For a student like Emily, who struggled with her learning disability before attending Archbishop Ryan, the Bonaventure program offered a turning point in her education. After graduation, she struggled in a four-year college, and took a year off. But persistence and patience learned at Archbishop Ryan encouraged her to try again. Her second attempt at college was tremendously successful, and from her perspective, if she hadn't had the Bonaventure Program she would not have had the courage to try again and succeed.

"I think for me, and I try to tell this to my students: anything is possible. There are three components needed for our students to succeed: their academic teacher has to do their job, I have to do my job teaching the Bonaventure Program, and our students have to do their job. I'm proud of the fact that our faculty is on board with everything — and with their help, anything is possible," said Bonaventure Program teacher Maureen Dougherty.

UNLEASHING COMMUNITY POTENTIAL

DRIVING EXCELLENCE THROUGH LOCAL GIVING

In 2013, Tom and Patty Lynch founded the Danaher Lynch Family Foundation, with the intention to give back to their local community and especially to their alma maters, Bishop Conwell and Bishop Egan. The Foundation's mission statement is "To help unleash the potential of the people in our community," which they achieve primarily through the support of Catholic education in their local area.

Tom and Patty and their extended family recognize the important role that Catholic education played in their own lives. Through scholarships they are able to help others receive the same quality education.

Sue DiLisio, Executive Director for the Foundation, and Tom's sister, emphasizes that they see "a true need for Catholic schools to remain part of the educational landscape. The value proposition they offer is a mark of the need in the community and the opportunity available."

The Danaher Lynch Foundation offers scholarships to students who wish to attend Conwell-Egan, but who may not be able to financially. The application process looks at the whole student, looking for a well-rounded individual who can benefit from the academic, extra-curricular, and community service opportunities available at Conwell-Egan. Whenever possible, they offer scholarships to students who have faced and are overcoming challenges in their own lives.

The first year, scholarships for the Class of 2019 started with four students, with a scholarship renewable for all four years of high school. Growing by leaps and bounds, the second class included twenty students for the Class of 2020, with another commitment to 29 additional students for the class of 2021.

To better support and recognize Conwell-Egan's continued excellence in Fine Arts, a few scholarships for the Class of 2021 were reserved for students who excel in the arts. These scholarships complement Conwell-Egan's existing programs, and work to create a great holistic educational experience. The Danaher Lynch Foundation looks to build a community of individuals who will continue giving back to society.

"We believe in supporting these students. Not just the financial support but to establish a network and a family of scholars. Our goal is to give them access to things that will help them prepare for scholarly endeavors down the road," DiLisio shared. "What better investment can you have than in a student? They're our future. That's the reason we invest at DLFF."

FAITH IN THE FUTURE'S STRATEGIC DIRECTION

DRIVE SCHOOL ACADEMIC QUALITY AND CREATE ADDED VALUE FOR FAMILIES

At the June 2016 board meeting when the Faith in the Future board of directors approved organizational priorities for the year, they also highlighted the need for a long-term strategic plan for the high school system. As Faith in the Future CEO Samuel Casey Carter puts it, "Instead of managing what we have, we were challenged to build what we need to support the high schools as a system over the long haul."


Working through a steering committee made up of Faith in the Future board members and Office of Catholic Education staff members, Carter led a year-long process to arrive at two core results: 1) a comprehensive data analysis of each school's local competitive situation and 2) a new system level strategy to address the shared needs of the schools across the system.

Parthenon/EY was selected as a technical partner on this project for their rich subject area expertise as consultants specializing in education and for their deep quantitative and analytical skills. Over the course of the project from February to August three work flows came together: a comprehensive fact base of demographic and survey data for each school; customer demand research that examines why parents and students choose our schools; and a central services audit of all of the services we bring to our schools today, so we can better understand what we need to do differently to serve our schools better in the future.

Each of the schools now has data around current enrollment, demographic trends in their area, family income and affordability measures, and market research as to where our schools rank in the consideration set of schools a student might choose to attend. Essentially, the schools each have the data and a toolkit to help them address three key issues: academic quality, enrollment, and cost. Our goal now, as a system, is to examine and address the interrelationship of those three at each school and for the system as a whole. As evidenced by the graph to the left, the overall satisfaction with our schools reflects a position of strength. Over 80% of parents indicated that they are more than satisfied with the high school their child attends. However, we will continue to work to build this satisfaction level to an even higher level, focusing on our four burning platforms of academic quality, enrollment, affordability, and Catholic identity.

Now that our governance structure is designed to make school boards more autonomous, this data gives our newly engaged school boards working with their administrative teams the data and information that they need to make better strategic decisions at the local level. For Faith in the Future and the Office of Catholic Education, we too can use this data to create a new strategic plan and inform our new support model which recognizes that the best decisions are those that are made at the individual school level. Our job from here is to put a new support model underneath them to help make their work easier to do, more cost effective, and ultimately focused on improving all aspects of school quality.

Over the year ahead, as our engagement with the Parthenon/EY data continues, the ultimate goal is to drive academic quality and build a new school support model that adapts to the changing needs of the students we serve and makes our schools the best value available in Philadelphia education.


ACADEMIC QUALITY

EMPHASIZING ACADEMIC QUALITY ACROSS THE SYSTEM

As part of our strategic planning project (see page 18 for more information), rigorous customer demand research was done. As the below chart shows, the most important factors for parents in choosing Archdiocesan high schools for their child are the quality of teachers in our schools, the ability of teachers to meet a student's needs, and academic quality and rigor.

The above data has clarified for us that Catholic identity is a very important factor for prospective parents, as is academic quality and affordability, which has allowed us to focus our new strategic plan on our four burning platforms of academic quality, enrollment, affordability, and Catholic identity. With these elements in mind, we aim to continue growing our schools to provide the best Catholic education available for our students.

ACADEMIC QUALITY IMPROVEMENT AT NEUMANN-GORETTI

As part of its strategic turnaround, Neumann-Goretti found a new way to approach improving academic quality. Since the spring of 2015, Neumann-Goretti has partnered with TNTP (The New Teacher Project), a national non-profit founded by teachers nearly twenty years ago to support school transformation efforts. TNTP visits every Neumann-Goretti faculty member's classroom in the fall and spring, rating the lesson they observe on a rigorous rubric for instructional quality.

At Neumann-Goretti, the number of teachers receiving one of the top 2 ratings (out of 5) on the student engagement section of the rubric has tripled, and the number of teachers receiving one of the top 3 ratings (out of 5 possible ratings) on the rigorous academic content section of the rubric has doubled since the spring of 2015. This partnership has improved the quality and effectiveness of instruction at the school, and ensures that students are taught to mastery before proceeding to the next step.

Additionally, they have rebranded as a college preparatory academy in an effort to shift the perception of the school and commit to providing a college preparatory education. The goal is to continue to coach their teachers, have their teachers experience growth and, as a byproduct of that growth, improve student outcomes.

STUDENT SPOTLIGHT:

"Attending Cardinal O'Hara was an amazing four years, which I didn't expect at all. I was very shy entering, but now I feel like an ambassador for Cardinal O'Hara. Catholic education is very important to me. I learned even more about the morality and ethics of Catholicism. The phenomenal teachers and classes available to me made such a difference. My teachers always helped me if I needed help, staying after school, especially my AP (Advanced Placement) teachers. AP is a great way to expand your knowledge and see how far you can go. They're tough, they're college courses, but the fact that I experienced it before college was amazing. It made me want to work harder, and to do well in my work, not just get it done. I'll carry with me all the wise words I've heard at O'Hara. Every teacher impacted my experience and my life. I would not be who I am today without Catholic education and Cardinal O'Hara. I'm taking the community with me, and I'll definitely be back to give back whenever I can."

MAKING CATHOLIC EDUCATION AFFORDABLE

Faith in the Future aims to make Catholic education affordable for any family that desires it. Since the year 2000, more than 2,500 Catholic schools across the country have closed. Quite simply, affordability has become a significant barrier to entry for many families. Fortunately, the cost of Catholic education here in Philadelphia is among the very lowest in the United States. Still, it remains out of reach for thousands of parents forced to keep their children in failing schools or who would prefer a faith-based alternative to their public school options.

Today, across our 17 high schools and four schools of special education, we are educating nearly 13,000 students with a capacity to serve many more.



INVESTING IN INSTRUCTIONAL I FADERSHIP

PRINCIPALS LEADERSHIP ACADEMY



The Principals Leadership Academy (PLA), designed and developed by Sr. Maureen McDermott, IHM, Chief Academic Officer and Superintendent for Secondary Schools, is a foundational program in our renewed effort to train our academic leaders to best serve their teachers and students.

Designed to create strong instructional teams, the PLA incorporated several individuals from each school, including the Principal, the Assistant Principal for Academic Affairs, the English Department Chairperson, and the Curriculum Chairperson. The cohort met seven times during the year.

"The 2016-2017 Principals Leadership Academy was a welcome networking and professional learning opportunity to share successes and discuss challenges with colleagues in the first year Principal cohort of the AOP high schools," shared Hugh Quigley, Principal of Neumann-Goretti High School. "The shared reading of School Leadership for Results laid the foundation of our insightful conversations with each other, our Superintendent, & Assistant Superintendent throughout the school year."

During each Leadership Academy session, participants reviewed and connected with prior learning, learned processes and content to be implemented in their schools, and worked to apply theory into vision, action, and influence. In turn, this encouraged the academic leaders within our schools to embed strategies to promote teacher and principal growth, engage in networking and accountability, and ultimately, create systems of change.

The lasting impact of the Principals Leadership Academy is apparent after only one year. Each school has developed their own Professional Learning Communities to imbed the professional development into their daily work.

"The Principals Leadership Academy was a great opportunity for new principals who faced the same challenges to come together to discuss strategies and ways to enhance our leadership abilities," said James Strandberg, Principal of Bonner & Prendie. "It was great to have a support system starting with the leadership at the Office of Catholic Education through our fellow principals."

SUMMER BRIDGE PROGRAM

PROVIDES ACADEMIC AND COMMUNITY SUCCESS



In 2016, a new pilot program was introduced at Father Judge High School, designed as a fast-track academic readiness program for urban students to prepare for their freshman year at an Archdiocesan college prep school. This program originated to anticipate and address the needs of students who have been identified as being at risk of failing classes their freshman year.

The success of this program was extraordinary. Students attending the program had no learning regression during the summer months — as is typical for most students over the long vacation — and were reported to have no failures in the first quarter — which, unfortunately, is also common for children coming from difficult circumstances. Besides this academic success, the freshmen developed a sense of community and belonging before their first semester even began.

The program extended to three sites for 2017: Father Judge, Bonner & Prendie, and Roman Catholic. The Father Judge site hosted the students from Father Judge, Little Flower, and St. Hubert. The Roman Catholic site hosted the students from Hallahan and Neumann-Goretti. The Bonner & Prendie site hosted students from Bonner & Prendie, West Catholic, and Cardinal O'Hara.



An Arch-Ed (Archdiocesan Educational Fund) grant currently funds this program for incoming ninth-graders. The Archdiocesan Educational Fund supports Catholic education and programmatic initiatives such as the Summer Bridge Program. With grants like this, the Faith in the Future Access & Achievement Initiative continues to drive change and expand programming for our students.

As another example of the Access and Achievement Initiative in action, more staffing will support students who need extra attention: ACE teachers from Saint Joseph's University and the University of Notre Dame will help support additional instruction hours in mathematics and English Language Arts while also reducing class size for ninth grade classes in 2017-2018.

This emphasis on preparation for incoming ninth-graders and teacher support for freshmen will ensure that students at Archdiocesan high schools are set up for success, and provided with extra groundwork as they enter a college preparatory school.







TECHNOLOGY INTEGRATION COACHES

HELP, GUIDE, AND SUPPORT TECHNOLOGY ENABLED LEARNING



For Director of Technology, William Brannick, one of the changes needed to enhance the educational experience of our students was a change of mindset at the instructional level. He worked to change the idea of professional development regarding technology from a "Professional Development Day"

to the mindset of continuous learning opportunities for our teachers and administrators to better infuse technology in day to day classroom environments.

To make this a reality, Brannick has restructured his department to include Technology Integration Coaches — experts in the field who stay up to date and on trend in educational technology. They participate in their own professional development and create it for the teachers and administrators in our schools as well. These coaches visit classrooms throughout the Archdiocese to work with teachers to offer personalized professional development in the field of technology.

Brannick's first year as the head of the technology team was 2014-2015, and he knew he wanted to start rolling this out. In 2015-2016 the first Technology Integration Coach was hired, with another added in 2016-2017, and a third joining the team before the start of the 2017-2018 school year. With a third coach on board, they will each work with 4-6 high schools and at the elementary level to give personalized tech coaching to the teachers in their cohort. This allows them to work more directly with instructors, educators, and administrators, and better integrate updated technology into current projects, while also introducing new projects.

"Over the past two years, it has been amazing to watch the growth in confidence and EdTech knowledge of our teachers across the whole Archdiocese. I have witnessed a definite shift from administrator-focused initiatives to educator-led goals and discussion around technology integration. Teachers are exploring new tools, integrating new best practices, and making tech "their own" because they know the Technology Integration Coaches are there to help, guide, and support their efforts every step of the way," says Alissa N. DeVito, Associate Director of Educational Technology and the first Technology Integration Coach in the Archdiocese of Philadelphia.

This teacher-led exploration of new practices has additional benefits, like cutting paper from a classroom, connecting with classrooms outside the school either in the Archdiocese or throughout the country, and providing the students with choices as to how they do their work. In addition, the Technology Integration Coaches send out monthly newsletters for teachers and parents highlighting key trends and best tools, and run a webinar series to help a broad range of teachers on a given topic. The coaches role model the idea of continuous learning for all educational staff throughout the archdiocese.

"The underlying theme is that we progress and focus educational technology for our teachers and students. While the technology hardware and software is great, the tech is there as another tool to support learning. Certainly it takes resources to provide tech across our schools in an equitable way but our goal is always to drive learning across all mediums in the most efficient way and to get the teachers to not focus on the tech but keep the focus on education," says Brannick.









THE ARCHDIOCESAN SCHOOLS OF SPECIAL EDUCATION

PROVIDING EVERY STUDENT WITH THE OPPORTUNITY OF A CATHOLIC EDUCATION

At Archbishop Ryan Academy for the Deaf and St. Lucy School for Children with Visual Impairments, the students not only follow the same rigorous academic curriculum as the rest of the Archdiocese, they also get to celebrate Mass with a priest who speaks American Sign Language, and takes the time to answer their personal questions about faith. At St. Katherine Day School and Our Lady of Confidence, students form friendships with Bishop McDevitt and Archbishop Carroll students, making "Best Buddies" day the best day of the week.

This Catholic community is what makes the difference for many of our students, not just in their day-to-day life, but in how they grow over time. For many parents of children with special needs, finding a Catholic education option for their child is something they are grateful for every day.

As parent Patti Tulskie says of her daughter's education: "It gives our whole family a faith-based education, while meeting her individual needs." The schools of special education serve not only the student, but their families as well. With two other children who spent K-12 in Catholic school, Patti's daughter Muffy is able to have a similar educational experience. The goal of the schools of special education is to help each student reach their fullest potential through individualized education plans. Catherine Florig also shares her heartfelt sentiments regarding her son Matthew's educational and spiritual journey. "My son Matthew attends Our Lady of Confidence. From the moment I toured the program, I knew this was our home. OLC provides a multitude of opportunities for students, while in a nurturing Catholic environment. I have three children and all are blessed with a Catholic school education."

Cheryl Rodgers agrees. Her oldest children graduated from Kennedy-Kenrick Catholic High School and Pope John Paul II High School. Finding the right option for her youngest son, Matthew, was different. "Matthew is a student at, arguably, the best school the Archdiocese of Philadelphia has to offer . . . St. Katherine Day School. I couldn't appreciate, respect or cherish a school more than St. Katherine Day School. So, when the time to enroll Matthew in school was approaching, my husband and I were in a dilemma. We wanted for him what our older children had . . . a quality, Catholic education. But, since Matthew has Down syndrome, we figured our choices were, at best, limited. Until we found St. Katherine Day School. What St. Katherine Day School gives kids, well it can't be found anywhere else."

Kim Lengel's experience with St. Lucy's Day School for the Visually Impaired/Archbishop Ryan Academy for the Deaf resonates as well. "This positive environment is something I have been fortunate to witness since my daughter first enrolled at SLDS/ARAD. I recently attended my daughter's report card conference and was reminded of just how lucky we are to have a SLDS/ARAD education available to her. The academic, spiritual, and social environment is amazingly supportive, yet appropriately challenging. Through parent's groups in which I participate, I know about the school options that exist nationally for kids with visual impairments, and SLDS/ARAD is among the best of those. I am fully invested in my daughter becoming a contributing member of society and the staff at SLDS/ARAD are right there with me."

For many parents, the option of a Catholic education for a student with special needs is a difference-maker in their child's life. Each student at the Archdiocesan schools of special education is provided with the resources that nurture the skills, knowledge, and confidence needed to develop their God-given potential, all in a Catholic environment.



SPECIAL EDUCATION UPDATE

From the Desk of Andrew McLaughlin, Director of Special Education

"The special education programming that we provide in Catholic schools is distinct because our students receive quality instruction that allows them to make progress in academic areas in a

Christ-centered learning environment. A lower student to teacher ratio enables our teachers to focus on the individual needs of our students.

In the last several years, the special education program within the Archdiocese of Philadelphia has grown on many fronts. We have seen the growth of inclusive practices in all levels of the Archdiocesan Schools. This growth has been realized in the form of creating additional services as well as enhancing the pedagogical practices within our schools.

Our schools of special education have added a dedicated program for students on the autistic spectrum. This program serves students that have been diagnosed with level two or level three ASD. Although a dedicated program for students with level two and three of ASD is being offered at St. Katherine Day School, we have also offered support for students with level one ASD within all of our elementary and high schools within the Archdiocese. Staff at St. Katherine Day School will offer consultative support to all the schools and help train teachers and design a program that meets the child's needs within the inclusive setting. Additionally, we have seen the addition of counseling services at our schools and in some schools, music therapy. Our schools of special education are growing their reputation and are now receiving referrals from many new sources.

Two of our high schools, Saints Neumann and Goretti and Little Flower High School have added dedicated support classrooms. These programs will allow the schools to provide additional support to students with academic needs. The schools will be able expand the scope of students that they accept into their college preparatory programs. In addition to providing direct services to students, they will also support student's needs while in the general curriculum classes."

Funded by a generous grant from the Raskob Foundation for Catholic Activities, Faith in the Future is pleased to welcome Melissa DiNofia-Bozzone as the new Director of Advancement for Special Education.

Melissa will work directly with the four schools to create a board, raise awareness, and fundraise to support the important work happening in the Archdiocesan schools of special education. In partnership with the director of Special Education, she will also focus on K-12 initiatives in the mainstream.

"I am honored to share that in my newly created role as Director of Advancement for Special Education, I will focus primarily on outreach, awareness, advocacy, and fundraising initiatives related to our four Schools of Special Education. I am thrilled to have the opportunity to work with St. Katherine Day School, Our Lady of Confidence Day School, St. Lucy Day School for the Visually Impaired, and Archbishop Ryan Academy for the Deaf.

My professional world has found me in school environments for my entire career, both in higher education and the independent school world. As a parent of a child who is deaf, my personal journey as an advocate for our daughter Madeline has been my most meaningful work. I am humbled to have the opportunity to connect both my professional skill sets and personal passions through the work ahead with our schools of Special Education and through our initiatives in the mainstream.

Within the next year, the goal is to engage more partners in our good work. One of our top goals would be to form one governing board for our Schools with a wide range of expertise including finance, fundraising, marketing, facilities, enrollment management, mission and identity, and much more. We look forward to growing a dedicated team of volunteers to ensure the ever-changing needs of all our schools. We are committed to finding the hearts and hands to help us ensure the viability and sustainability of our programs for generations to come."

In a speech marked by their humility, both Mark and Ann praised local Catholic school teachers. PRESIDENTS & ADVANCEMENT STAFF

LEARN THE PRINCIPLES OF FUNDRAISING

In an ongoing effort to professionalize high school advancement processes and procedures, Faith in the Future invited presidents and advancement staff to participate in the Principles of Fundraising course presented by Villanova University. Participants included presidents and advancement staff representing our schools.

In early fall of 2016, and again in the spring of 2017, presidents and advancement staff representing archdiocesan high schools joined other nonprofit management and development professionals from throughout the greater Philadelphia to delve into 12 weeks of focused instruction and discussion covering the fundamental tenets of fundraising. Each week students were presented with tools and data driven solutions which resulted in a portfolio of strategies and skills to implement goal setting, strategic outreach, and communication with donors.

In the case of presidents and advancement staff, such strategies could be applied directly to the development plans and planning process that each high school creates and manages with Faith in the Future staff.

Offered in collaboration with the Association of Fundraising Professionals – Greater Philadelphia Chapter (AFP-GPC), the courses are taught by seasoned development professionals with a breadth and depth of expertise to share with students of all levels. Topics included creating and managing an annual giving program, multimedia communication strategies, hosting solicitation events, and strategies for engaging major donors. The course was designed not only to offer informative content and resources, but also as an open forum for asking questions and exchanging ideas.

As part of its investment in the quality of professionals and support of fundraising efforts at all of the high schools, Faith in the Future offered scholarships to interested presidents and staff to make the course more accessible and serve as an incentive for increased participation.

After completing the course, presidents and advancement staff reported that the course was a worthwhile investment of time, offering valuable resources and the opportunity to connect with other professionals in the field.

Kristin Conran, Director of Major Gifts and Business Outreach at Bishop McDevitt High School, shared her positive experience. "When Faith in the Future offered the opportunity to attend the Principles of Fundraising course at Villanova, I immediately responded with a YES! I was impressed with the instructors and the deep dive into the content that was covered. Weekly discussion with other professionals who were looking to enhance their philanthropic endeavors was extremely beneficial."

With the success of the initial cohort, Faith in the Future offered the Principles of Fundraising course as a resource for professional development in the fall of 2017.




